



Privacy Notice for Governors

The categories of governance information that we process include:

- ▶ personal identifiers, contacts and characteristics (such as name, date of birth, contact details and postcode)
- ▶ governance details (such as role, start and end dates and governor ID)
- ▶ Information about business and pecuniary interests
- ▶ Information relating to any specialist skills or professional qualifications you may have
- ▶ DBS Information for Safeguarding

We may also collect, store and use information about you that falls into “special categories” of more sensitive personal data. This may include information about (where applicable):

- ▶ Race, ethnicity, religious beliefs, sexual orientation and political opinions
- ▶ Disability and access requirements

Why we collect and use governance information

The personal data collected is essential, in order for the school to fulfil their official functions and meet legal requirements.

We collect and use governance information, for the following purposes:

The purpose of processing this data is to support our Schools and the Trust to:

- ▶ Establish and maintain effective governance
- ▶ Meet statutory obligations for publishing and sharing governor’s and trustee’s details
- ▶ Facilitate safe recruitment, as part of our safeguarding obligations towards pupils
- ▶ Undertake equalities monitoring
- ▶ Ensure that appropriate access arrangements can be provided if required

Our lawful basis for using this data

We only collect and use personal information about you when the law allows us to.

Most commonly, we use it where we need to:

- ▶ Comply with a legal obligation
- ▶ Carry out a task in the public interest

Less commonly, we may also use personal information about you where:

- › You have given us consent to use it in a certain way
- › We need to protect your vital interests (or someone else's interests)

All maintained school governing bodies, under [section 538 of the Education Act 1996](#) and academy trusts, under the [Academies Financial Handbook](#) have a legal duty to provide the governance information as detailed above.

Collecting governance information

Governance data is essential for the school's operational use. Whilst the majority of personal information you provide to us is mandatory, some of it may be requested on a voluntary basis. In order to comply with GDPR, we will inform you at the point of collection, whether you are required to provide certain information to us or if you have a choice in this.

Who we share governance information with

We routinely share this information with:

- › Government departments or agencies – to meet our legal obligations to share information about Governors and Trustees
- › Suppliers and service providers – to enable them to provide the service we have contracted them for, such as Governor/Trustee support
- › Our auditors – to meet requirements of external audits and comply with the relevant statutory bodies
- › Professional advisers and consultants – to meet our statutory obligations
- › Police forces, courts, tribunals – to meet any legal, safeguarding and child protection requirements
- › Other Professional bodies – as deemed appropriate by the Senior Leadership Team
- › Solicitors and other legal entities – as deemed necessary in connection within your capacity as a Governor/Trustee
- › Our Local Authorities – PCC & DCC
- › The DfE – Department for Education
- › The ESFA – Education, Skills & Funding Agency
- › The RSC – The Regional Schools Commissioners

Why we share governance information

We do not share information about individuals in governance roles with anyone without consent unless the law and our policies allow us to do so.

Department for Education

The Department for Education (DfE) collects personal data from educational settings and local authorities. We are required to share information about individuals in governance roles with the Department for Education (DfE), under:

All data is entered manually on the GIAS system and held by DfE under a combination of software and hardware controls which meet the current [government security policy framework](#).

Requesting access to your personal data

Under data protection legislation, you have the right to request access to information about you that we hold. To make a request for your personal information, contact the Trust Data Protection Officer.

You also have the right to:

- to ask us for access to information about you that we hold
- to have your personal data rectified, if it is inaccurate or incomplete
- to request the deletion or removal of personal data where there is no compelling reason for its continued processing
- to restrict our processing of your personal data (i.e. permitting its storage but no further processing)
- to object to direct marketing (including profiling) and processing for the purposes of scientific/historical research and statistics
- not to be subject to decisions based purely on automated processing where it produces a legal or similarly significant effect on you

If you have a concern or complaint about the way we are collecting or using your personal data, you should raise your concern with us in the first instance or directly to the Information Commissioner's Office at <https://ico.org.uk/concerns/>

Withdrawal of consent and the right to lodge a complaint

How Government uses your data

The governance data that we lawfully share with the DfE via GIAS:

- will increase the transparency of governance arrangements
- will enable maintained schools and academy trusts and the department to identify more quickly and accurately individuals who are involved in governance and who govern in more than one context
- allows the department to be able to uniquely identify an individual and in a small number of cases conduct checks to confirm their suitability for this important and influential role

Note: Some of these personal data items are not publically available and are encrypted within the GIAS system. Access is restricted to a small number of DfE staff who need to see it in order to fulfil their official duties. The information is for internal purposes only and not shared beyond the department, unless the law allows it.

How to find out what personal information DfE hold about you

Under the terms of the Data Protection Act 2018, you're entitled to ask the Department:

- if they are processing your personal data
- for a description of the data they hold about you
- the reasons they're holding it and any recipient it may be disclosed to
- for a copy of your personal data and any details of its source
